PROFESSIONAL SERVICES AGREEMENT

AGREEMENT NO. PS-899

This agreement, dated as of the 9th day of **August, 2005**, but actually executed on the date witnessed hereinbelow, by and between the **Public Building Commission of Chicago**, a municipal corporation of the State of Illinois, having its principal office at Room 200, Richard J. Daley Center, 50 West Washington Street, Chicago, Illinois 60602, referred to in this Agreement as the "**Commission**", and **Willis of Illinois, Inc.** a Corporation, with offices at 10 South LaSalle Street, Chicago, Illinois 60603 referred to in this Agreement as the "**Benefits Consultant**" or "**Consultant**",

WITNESSETH:

WHEREAS, the Commission requires certain professional services, described on Schedule A to this Agreement (the "Services"), in connection with the Project and desires to employ the Consultant, on the terms and conditions set forth in this agreement, to perform such Services; and

WHEREAS, the Consultant desires to be so retained by the Commission and has represented to the Commission that the Consultant has the knowledge, skill, experience and other resources necessary to perform the Services in the manner herein provided; and

WHEREAS, the Consultant has consulted with the Commission, reviewed the Documents (defined below) and taken such other actions as the Consultant has deemed necessary or advisable to familiarize itself with the scope and requirements of the Project and the Services;

NOW, THEREFORE, for valuable consideration, the Commission and the Consultant agree as follows:

1. INCORPORATION OF RECITALS

The matters recited above are hereby incorporated in and made a part of this agreement.

2. DEFINITIONS

The following phrases have the same meanings for purposes of this Agreement:

a. **Agreement**

This professional services Agreement, including all exhibits or documents attached hereto and/or incorporated by reference herein, and all amendments, modifications, or revisions made in accordance with the terms hereof.

b. **Commission**

The Commission's Chairman, Secretary, Assistant Secretary, Executive Director, Chief of Staff, Director of Construction, Managing Architect, Director of Procurement, Project Manager, or designated consultant or consultants, acting on behalf thereof, as designated by the Commission

in writing, for the purpose of giving authorizations, instructions, and/or approval pursuant to this Agreement.

c. Contract Documents

The component parts of the Contract between the Commission and the insurer(s), including but not limited to any memorandums of understanding, binders, agreements, policies or modifications thereto.

d. Consultant

Also referred to as the Benefits Consultant, means the company, or other entity identified in this Agreement as the party providing these services to the Commission, and such successors or assigns, if any, as may be authorized by the terms and conditions of this Agreement.

e. Key Personnel

Job titles and persons as identified in those positions as identified in the Consultant's proposal and accepted by the Commission.

f. Program

The system of benefits coverage agreed upon by the Consultant and the Commission.

g. Services

Collectively, the services duties and responsibilities that are necessary to allow the consultant to provide the Services required by the commission under this Agreement. The required Services are described in Schedule A of this Agreement.

h. Sub-consultant

a firm hired by the Consultant to perform professional services related to the program.

i. Technical Personnel

Includes partners, officers and all other personnel of the Consultant, including technical typists assigned to the Project, exclusive of general office employees.

3. INCORPORATION OF DOCUMENTS

The documents identified below in this paragraph are hereby incorporated in and made a part of this Agreement. By executing this Agreement, Consultant acknowledges and agrees that Consultant is familiar with the contents of each of such documents and will comply fully with all applicable portions thereof in performing the Services.

a. Program Documents

The analyses, reports, recommendations and conclusions regarding the program, including but not limited to quotations, asset listings, as set forth and described in the Scope of this Agreement.

b. Policies Concerning MBE and WBE

The Commission's policies concerning utilization of minority business enterprises ("MBE") and women business enterprises ("WBE"), as the same may be revised from time to time.

4. ENGAGEMENT AND STANDARDS FOR PERFORMING SERVICES

a. Engagement

The Commission hereby engages the Consultant, and the Consultant hereby accepts such engagement, to provide the Services described in Schedule A to this agreement. The Services may be amended from time to time by mutual agreement of the Commission and the Consultant.

b. Nondiscrimination

In performing this Agreement the Consultant will not discriminate against any worker, employee, applicant for employment, or any member of the public, because of race, color, creed, national origin, gender, age, or disability, or otherwise commit an unfair labor practice. The Consultant certifies that he/she is familiar with, and will comply with, all applicable provisions of the Civil Rights Act of 1964, 28 U.S.C. § 1447, 42 U.S.C. §§ 1971, 1975a-1975d, 2000a to 2000h-6 (1992); the Age Discrimination in Employment Act of 1967, 29 U.S.C. §§ 623-634 (1992); the Americans with Disabilities Act of 1990, 29 U.S.C. § 706, 42 U.S.C. §§ 12101-12213, 47 U.S.C. §§ 152, 221, 225, 611 (1992); 41 C.F.R. § 60 (1992); 41 C.F.R. § 60 (1992); reprinted in 42 U.S.C. 2000(e) note, as amended by Executive Order No. 11,375 32 Fed. Reg. 14,303 (1967) and by Executive Order No. 12,086, 43 Fed. Reg. 46,501 (1978); the Age Discrimination Act, 43 U.S.C. Sec. 6101-6106 (1981); P.L. 101-336; 41 C.F.R. part 60 et seq. (1990); the Illinois Human Rights Act, 775 ILCS 5/1-101 et seq. (1990), as amended; the Discrimination in Public Contracts Act, 775 ILCS 10/0.01 et seq. (1990), as amended; the Environmental Barriers Act., 410 ILCS 25/1 et seq; and the Chicago Human Rights Ordinance, Chapter 2-160, Section 2-160-010 et seq. of the Municipal Code (1990), as amended. The Consultant further agrees to furnish such reports and information as may be requested by the Commission, the Illinois Department of Human Relations, or any other administrative or governmental entity overseeing the enforcement or administration of, or compliance with, the above mentioned laws and regulations.

c. Employment Procedures, Preferences and Compliances

The Consultant performing work under this Agreement unconditionally and not less often than once a month, must pay the salaries of its employees without deduction or rebate on any account except only such payroll deductions as are mandatory or permitted by the applicable law or regulations. The Consultant certifies that he/she is familiar with, and will comply with, all applicable provisions of 820 ILCS 130/0.01 through 130/12 thereof (Prevailing Wage Act), 30 ILCS 570/1 through 570/7 (Employment of Illinois Workers on Public Works Act) and 30 ILCS 560/0.01 through 560/7 (Public Works Preference Act). The Consultant must also comply with all applicable "Anti-Kickback" laws and regulations, including the "Anti-Kickback" Act of 1986, 41 U.S.C. §§ 51-58 (1992); 18 U.S.C. § 874 (1992); 40 U.S.C. § 276c (1986) and the Illinois Criminal Code of 1961 720 ILCS 5/33E-1 et. seq. If, in the performance of this Agreement, there is any direct or indirect "kick-back", as defined in any of the above mentioned laws and regulations, the Commission may withhold from the Consultant, out of payments due it, an amount sufficient to pay any underpaid employees the difference between the salaries required by law to be paid and the salaries actually paid such employees for the total number of hours worked. The amounts withheld may be disbursed by

the Commission for and on account of the Consultant to the respective employees to whom they are due, as determined by the Commission in its sole discretion.

d. Compliance with Policies Concerning MBE and WBE

Without limiting the generality of the requirements of the policies of the Commission referred to in paragraph 2 above, the Consultant will use every reasonable effort to utilize minority business enterprises for not less than twenty five percent (25%) for MBE and five percent (5%) for WBE of the value of the Services, in accordance with the Resolution passed by the Board of Commissioners of the Commission on October 1, 2004, concerning participation of minority business enterprises and women business enterprises on contracts awarded by the Commission and to furnish to the Commission, such reports and other information concerning compliance with such Resolution as may be requested by the Commission from time to time.

e. Delays

The Consultant agrees that no charges for damages or claims for damages will be asserted by it against the Commission for any delays or hindrances from any cause whatsoever during the progress of any portion of the Services. Such delays or hindrances, if any, will be compensated for by an extension of time to complete the Services, for such reasonable period as may be mutually agreed upon between the parties, it being understood, however, that the agreement of the Commission to allow the Consultant to complete the Services or any part of them after the time provided for the completion thereof herein will in no way operate as a waiver on the part of the Commission of any of its rights hereunder.

f. Records

The Consultant will maintain accurate and complete records of expenditures, costs and time incurred by Consultant in connection with the Services. Such records will be maintained in accordance with recognized commercial accounting practices. The Commission may examine such records at Consultant's offices upon reasonable notice during normal business hours. Consultant will retain all such records for a period of not less than five calendar years after the termination of this agreement.

g. Time of Essence

The Consultant acknowledges and agrees that time is of the essence in the performance of this Agreement and that timely completion of the Services is vital to the Commission. Consultant agrees to use its best efforts to expedite performance of the Services and performance of all other obligations of the Consultant under this Agreement and any other agreements entered into by the Commission which are managed or administered by the Consultant as a result of the Consultant's engagement hereunder.

Notwithstanding the foregoing, the Consultant does not guarantee or make any representation or warranty the insurance can be placed on terms proposed by the Commission.

h. Compliance with Laws

In performing its engagement under this Agreement, the Consultant will comply with all applicable federal, state and local laws, including but not limited to, those referenced in subparagraphs (b) and (c) above and in the documents referred to in paragraph 3 of this agreement.

i. Progress Meetings

Meetings to discuss the program and/or to review the performance of the Consultant may be scheduled upon the Commission's request, at mutually agreeable times and locations, and the Consultant agrees to cause such meetings to be attended by appropriate personnel of the Consultant engaged in performing or knowledgeable of the Services.

j. Defects in Project

The Consultant will notify the Commission immediately in the event the Consultant obtains knowledge of a defect or circumstances that could result in a Services delay or cost overrun.

k. Performance Standard

The Consultant represents and agrees that the Services performed under this Agreement will proceed with efficiency, promptness and diligence and will be executed in a competent and thorough manner, in accordance with reasonable professional standards in the field. The Consultant further agrees that it will assign to the engagement at all times during the term of this Agreement the number of experienced, appropriately trained employees necessary for the Consultant to perform the Services in the manner required hereunder.

l. Changes (Amendments)

The Commission may from time to time, request changes to the terms of the Agreement or in the Scope of Services of the Consultant to be performed hereunder. Such changes, including any increase or decrease in the amount of compensation and revisions to the duration of the Services, which are mutually agreed upon by and between the Commission and the Consultant, will be incorporated in a written amendment to this Agreement. The Commission will not be liable for any changes absent such written amendment.

m. Copyright Infringement

The Consultant represents and warrants to the Commission that (i) that the Consultant is the owner of numerous proprietary programs and documents that may be deemed "Literary Works" within the meaning and purview of Section 101 of the United States Copyright Act (17 U.S.C. Sec. 101 et. seq.) (The "Copyright Act"); (ii) that the Literary Works do not infringe or otherwise violate any copyright, patent, trade secret or any other intellectual property right that is protected by the Copyright Act; (iii) Consultant will notify the Commission promptly in writing in the event the Consultant receives notice of any claim which alleges that the Literary Works under by the Consultant in performing the Services under this Agreement violate the provisions of the Copyright Act; and (iv) Consultant will indemnify, defend and hold the Commission harmless from any claim or proceeding to the extent that it is based upon a claim that the Literary Works used with the scope of this Agreement infringe upon a patent or copyright, misappropriate a trade secret or otherwise violate the Copyright Act.

n. Insurers

The Consultant will be authorized for purposes of this agreement to represent and assist the Commission in all discussions and transactions with all insurers, provided that the Consultant will not place any insurance on the Commission's behalf unless so authorized. The Consultant will monitor published financial information of the current insurers used hereunder and alert the Commission when the status of one or more of such insurers falls

below the Consultant's minimum financial guidelines. The Consultant will not, however, be responsible for the solvency or ability to pay claims of any insurance carrier. Insurers with whom risks are placed hereunder will be deemed acceptable to the Commission, in the absence of contrary written instructions from the Commission.

5. TERM

a. Commencement

The term of this Agreement begins on the Commencement Date of Services specified in Schedule A, and subject to the provisions of subparagraph (b) below, expires upon completion of the Services and acceptance thereof by the Commission, or the anticipated Completion Date is specified in such Schedule A. The Commission and the Consultant may, from time to time, by mutual agreement, extend the term of this Agreement by amending Schedule A.

b. Termination or Suspension by the Commission

The Commission has the right, at any time, to terminate this Agreement, with or without cause, by written notice given to the Consultant at least 30 days before the effective date of termination. In addition, the Commission has the right, at any time and from time to time, with or without cause, to suspend the performance of the Consultant with respect to all or any part of the Services, by written notice given to Consultant at least 5 days prior to the effective date of suspension. Termination or suspension of this Agreement does not relieve the Consultant from liability for the performance of any obligation of Consultant under this Agreement performed or to have been performed by Consultant on or before the effective date of termination or suspension. Provided that the Consultant is not in default under this Agreement at the time of termination or suspension, the Commission will pay the Consultant, in accordance with the terms of this Agreement, all compensation and reimbursements due to Consultant for periods up to the effective date of termination or suspension. In no event will the Commission be liable to the Consultant for any loss, cost or damage, including lost profits which Consultant or any other party may sustain by reason of the Commission terminating or suspending this Agreement as provided above. However, the Commission may, in its sole discretion, reimburse the Consultant for actual expenses approved by the Commission. Provided the Consultant is not in default under this Agreement at the time of termination or suspension, the Commission agrees to pay the Consultant, in accordance with the following schedule: one payment per annum once all benefit coverages are bound.

c. Termination by the Consultant

If the Services, in whole or substantial part, is stopped for a period longer than 30 days under an order of any court or other governmental authority having jurisdiction of the Services, or as a result of an act of government, such as a declaration of national emergency making materials unavailable, through no act or fault of the Consultant, or if the Commission fails to make any payment or perform any other obligation hereunder, the Consultant has the right to terminate this Agreement, by written notice given to the Commission at least 7 days before the effective date of termination, and has the right to recover from the Commission all compensation and reimbursements due to the Consultant for periods up to the effective date of termination.

d. Force Majeure

Neither of the parties are liable to the other for any delay or failure in performance hereunder due to a force majeure event. If a force majeure event occurs, the party delayed or unable to perform must give prompt notice to the other party, and the Commission may, at any time during the continuation of the force majeure event, elect to suspend the performance of the Consultant under this Agreement for the duration of the force majeure event. The Commission is not obligated to pay for Services to the extent and for the duration that their performance is delayed or prevented by the force majeure event. If, however, the Consultant is not in default of any of its obligation hereunder, the Commission will pay the Consultant, according to the terms hereof, all compensation and reimbursements due to the Consultant for periods up to the effective date of suspension.

6. COMPENSATION OF THE CONSULTANT AND REIMBURSEMENT FOR EXPENSES

The Commission will compensate the Consultant in the amount and the manner set forth in Schedule C to this Agreement.

7. RIGHTS AND OBLIGATIONS OF COMMISSION

In connection with the administration of the Project by the Commission and the performance of this Agreement by the Consultant, the Commission has the following rights and obligations, in addition to those provided elsewhere in this Agreement (and specifically Schedule E):

a. Information

The Commission will provide the Consultant all reasonably requested information concerning the Commission's requirements for the Services.

b. Review of Documents

Subject to the provisions of subparagraph 3 (e) above, the Commission will make a reasonable effort to examine documents submitted by the Consultant and render decisions pertaining thereto with reasonable promptness.

c. Legal, Auditing and other Services

The Commission will arrange and pay for such legal, auditing, insurance counseling and other services as the Commission, in its sole discretion, may determine to be required for the Services. Such payments do not include legal or auditing expenses arising out of or relating to any errors or omissions, or claimed errors or omissions of the Consultant.

d. Designated Representatives

The Commission may designate, at its sole discretion, one or more representatives authorized to act in its behalf.

e. Indemnities

The Commission will require, by appropriate provision in each contract let by the Commission after the date of this Agreement with respect to the Project that the contractor or consultant thereunder must indemnify, save and hold harmless the Commission, and their respective commissioners, board members, officers, agents and employees, from all claims, demands, actions and the like, of every nature and description, made or instituted by third parties, arising

or alleged to arise from the work performed pursuant to such contract, and that the contractor or consultant thereunder must purchase and maintain during the life of such contract such insurance as the Commission may require.

f. **Ownership of Documents**

All documents, data, studies and reports prepared by the Consultant or any party engaged by the Consultant, pertaining to the Project and/or the Services are the property of the Commission.

g. **Audits**

The Commission has the right to audit the books of the Consultant and its sub-consultants on all subjects relating to the Project and/or the Services.

8. INDEMNIFICATION OF COMMISSION

The Consultant must defend, indemnify, keep and save harmless the Commission and their respective commissioners, board members, officers, agents, officials and employees (individually and collectively, the "Indemnitees"), from and against all liabilities, claims, demands, suits, losses, judgments, fines, or damages of every kind and nature, costs and expenses, including but not limited to, the reasonable fees and expenses of attorneys (including all reasonable costs for investigation, court costs and experts' fees related thereto) (individually and collectively, the "Losses"), that may arise out of or be based on any injury or death of any person or damage to property arising out of or incident to Consultant's performance or non-performance of this agreement or to errors, omissions or negligent or willful acts of the Consultant or any person employed by it, to the maximum extent permitted by applicable law. Such indemnity specifically excludes all Losses resulting from the errors and omissions of any sub-consultant employed by the Consultant to implement the Services except to the extent of the Consultant negligence in the administration and management of the work of such sub-consultants or specialty work that is self-performed by the Consultant.

9. INSURANCE TO BE MAINTAINED BY THE CONSULTANT

The Consultant must at its own expense obtain and maintain at all times during the performance of Services hereunder, for the benefit of the Commission, the Consultant, insurance coverage that will adequately insure the Commission, and the Consultant against claims and liabilities that could arise out of the performance of such Services, including but not limited to, the insurance coverages set forth in Schedule D to this Agreement.

10. DEFAULT

a. **Events of Default**

Any one or more of the following occurrences constitutes an Event of Default under this Agreement:

- i. Failure or refusal on the part of the Consultant duly to observe or perform any obligation or agreement on the part of the Consultant contained in this Agreement, which failure or refusal continues for a period of 10 days, or such longer period as the Commission, in its sole discretion, may determine if such failure is not capable of being

cured within such 10-day period, after the date on which written notice thereof has been given to the Consultant by the Commission;

- ii. Any representation or warranty of the Consultant set forth herein or otherwise delivered pursuant to the Request for Proposals to Provide Benefit Consulting Services for the Public Building Commission of Chicago or this Agreement that is false in any material respect when so made or furnished;
 - iii. The Consultant becomes insolvent or ceases doing business as a going concern, or makes an assignment for the benefit of creditors, or generally fails to pay, or admits in writing its inability to pay, its debts as they become due, or files a voluntary petition in bankruptcy, or is adjudicated a bankrupt or an insolvent, or files a petition seeking for itself any reorganization, arrangement, composition, readjustment, liquidation, dissolution, or similar arrangement under any present or future statute, law or regulation relating to bankruptcy or insolvency, or files an answer admitting the material allegations of a petition filed against it in any such proceeding, or applies for, consents to or acquiesces in the appointment of a trustee, receiver, liquidator or other custodian of it or of all or any substantial part of its assets or properties, or if it or its principals will take any action in furtherance of any of the foregoing; or
 - iv. There is commenced any proceeding against the Consultant seeking reorganization, arrangement, readjustment, liquidation, dissolution or similar relief under any present or future statute, law or regulation relating to bankruptcy which is not vacated, stayed, discharged, bonded or dismissed within 60 days thereof, or there is appointed, without the Consultant's consent or acquiescence, any trustee, receiver, liquidator or other custodian of Custodian or of all or any substantial part of the Consultant assets and properties, and such appointment has not been vacated, stayed, discharged, bonded or otherwise dismissed within 60 days thereof.
- b. Remedies
- If an Event of Default occurs and is continuing, then the Commission may exercise any right, power or remedy permitted to it by law or in equity and has, in particular, without limiting the generality of the foregoing, the right to terminate this Agreement upon written notice to the Consultant, in which event the Commission will have no further obligations hereunder or liability to the Consultant except as to payment for Services actually received and accepted by the Commission through the effective date of termination. No courses of dealing on the part of the Commission or delay or failure on the part of the Commission to exercise any right operates as a waiver of such right or otherwise prejudices the Commission's rights, powers or remedies.
- c. Remedies not Exclusive
- No right or remedy conferred under this agreement upon or reserved to the Commission is exclusive of any other right or remedy under this agreement or by law or equity provided or permitted, but each is cumulative of every other right or remedy given hereunder or now or hereafter existing at law or in equity or by statute or otherwise, and may be enforced concurrently therewith or from time to time.

11. DISPUTES

a. General

The Consultant must present in writing all disputes arising under, related to or in connection with the terms of this Agreement or its interpretation, whether involving law or fact or both, including without limitation questions concerning allowability of compensation, and all claims for alleged breach of contract, will be presented in writing to the Executive Director for final determination.

b. Procedure

Requests for determination of disputes will be made by the Consultant in writing specifically referencing this Section, and must include: 1) the issue(s) presented for resolution; 2) a statement of the respective positions of the Consultant and the Human Resources Manager; 3) the facts underlying the dispute; 4) reference to the applicable provisions of the Agreement by page and section; 5) identify any other parties believed to be necessary to the resolution; and 6) all documentation which describes and relates to the dispute. The Consultant must promptly provide the Executive Director with a copy of the request for determination of the dispute. The Human Resources Manager will have 30 business days to respond in writing to the dispute by supplementing the submission or providing its own submission to the Executive Director. Failure by the Human Resources Manager to respond is not an admission of any allegations made in the request for dispute resolution, but will be deemed to constitute a waiver of the opportunity to respond to such allegation(s), if any. The Executive Director may thereafter reach his decision in accordance with such other information or assistance as he may deem reasonable, necessary or desirable.

c. Effect

The Executive Director's final decision will be rendered in writing no more than 45 business days after receipt of the response by the Human Resources Manager was filed or was due unless the Executive Director notifies the Consultant that additional time for the decision is necessary. The Executive Director's decision will be conclusive, final, and binding on all parties. The Consultant must follow the procedures set out in this Section and receive the Executive Director's final decision as a condition precedent to filing a complaint in the Circuit Court of Cook County or any other court.

The Consultant must not withhold performance of any Services required by the Commission under this Agreement during the dispute resolution period. The Executive Director's written determination must be complied with pending final resolution of the dispute.

12. CONFIDENTIALITY

All of the reports, information, or data prepared or assembled by the Consultant under this Agreement are confidential, and the Consultant agrees that such reports, information or data will not be made available to any party without the prior written approval of the Commission. In addition, the Consultant must not, without the prior written consent of the Commission, prepare or distribute any news releases, articles, brochures, advertisements or other materials concerning this Agreement, the Services. If the Consultant is served with a subpoena requiring the production of documents or information that is deemed confidential, the Consultant must

immediately notify the Commission in writing and provide a copy of the subpoena to the Commission in sufficient time for the Commission to attempt to quash, or take other action in relation to the subpoena.

13. ASSIGNMENT

The Consultant acknowledges that the Commission is induced to enter into this Agreement by the personal qualifications of the principals, staff and employees of the Consultant and agrees, therefore, that neither this Agreement nor any right or obligation hereunder may be assigned by the Consultant, in whole or in part, without the prior written approval of the Commission. The Consultant further acknowledges that the Consultant has represented to the Commission the availability of certain members of the Consultant's staff who will be assigned to the engagement, and agrees, therefore, that in the event of the unavailability of such members due, the Consultant will so notify the Commission in writing, and will assign other qualified members of the Consultant's staff, as approved by the Commission, to the engagement.

14. RELATIONSHIP OF PARTIES

The relationship of the Consultant to the Commission hereunder is that of an independent contractor, and the Consultant, except to the extent expressly provided to the contrary on Schedule A hereto, will have no right or authority to make contracts or commitments for or on behalf of the Commission, to sign or endorse on behalf of the Commission any instruments of any nature or to enter into any obligation binding upon the Commission. This Agreement will not be construed as an Agreement of partnership, joint venture, or agency.

15. GENERAL

a. Counterparts

This Agreement may be executed in any number of counterparts, any of which will be deemed an original.

b. Entire Agreement

This Agreement constitutes the entire understanding and agreement between the parties hereto and supersedes any and all prior or contemporaneous oral or written representations or communications with respect to the subject matter hereof, all of which communications are merged herein. This Agreement must not be modified, amended or in any way altered except by an instrument in writing signed by both of the parties hereto.

c. Governing Law

This Agreement has been negotiated and executed in the State of Illinois and is to be construed under and in accordance with the internal laws of the State of Illinois.

d. No Waiver

The waiver by either party of any breach of this Agreement does not constitute a waiver as to any succeeding breach.

e. Non-liability of Public Officials

No Commission Board member, employee, agent, officer, or official is personally liable to the Consultant or its sub-consultants, and the Consultant and its sub-consultants are not entitled to, and must not attempt to, charge any of them with liability or expense or hold them personally liable to the Consultant or its sub-consultants under this Agreement.

f. Notices

All notices required to be given hereunder must be given in writing and must be hand delivered or sent by United States certified or registered mail, postage prepaid, addressed to Commission and to the Consultant at their respective addresses set forth above. If so given, such notice is deemed to have been given on the date of delivery, if delivered by hand, and on the second business day after mailing, if given by mail. The Commission or the Consultant may, from time to time, change the address to which notices hereunder are sent by giving notice to the other party in the manner provided in this subparagraph.

g. The Consultant

Execution of this Agreement by the Consultant is authorized by a resolution of its Board of Directors, if a corporation, or similar governing document if a partnership or a joint venture, and the signatures(s) of each person signing on behalf of the Consultant have been made with complete and full authority to commit the Consultant to all terms and conditions of this Agreement, including each and every representation, certification and warranty contained or incorporated by reference in it.

h. Severability

In the event that any provisions of this Agreement will be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions are not in any way affected or impaired thereby.

i. Successors and Assigns

Except as otherwise provided herein, this Agreement is binding upon and inures to the benefit of each of the parties hereto and their respective successors and assigns.

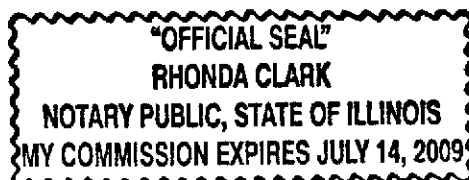

SCHEDULE A SCOPE OF SERVICES

A. Services

Willis of Illinois, Inc. will provide the Commission with various consulting services consisting of the following generalized categories and descriptions. Services will include, but are not limited to, the following:

1. Review and analyze operations and exposures.
2. Prepare applications and other insurance policy specifications, and review with Commission prior to submitting information to underwriters.
3. Design, market and implement coverage as identified in Exhibit A of the RFP, at the most reasonable cost and broadest terms.
4. In collaboration with the Commission's Human Resource Manager, develop a plan to establish activities, deliverables, and other matters pertinent to the requested services.
5. Identify those markets that are able to provide the insurance and services desired.
6. Develop the specification package for coverage outlined in Exhibits A, B, C, and D of the RFP presenting the risk exposure and other information in a form acceptable to underwriters.
7. Present insurance specifications to the marketplace, respond to underwriters' questions and provide additional information, if requested.
8. Receive and analyze underwriters' quotations. Determine whether they adhere to the specifications and that the premium quoted is fair and reasonable within the marketplace. Negotiate any changes and refinements on terms and/or conditions to obtain the most beneficial and cost-effective coverage available.
9. Submit insurance proposal to Commission's Human Resource Manager at least 60 days prior to expiration, providing a cost analysis by line of coverage, a matrix comparison of PBC's insurance specifications with the benefit plans quoted, and a recommendation. Analysis must include copies of all policy forms and endorsements to be included in the issued policies.
10. Place coverage upon Commission's approval.
11. Advise on claim-reporting procedures including contact personnel names and phone numbers. Identify and provide appropriate forms and instructions for use. (Such forms must have mailing address of primary recipients printed on them).

12. Review, validate and approve all premium invoices and billings regarding benefit plans and endorsements.
13. Provide immediate notice to the Commission of any change in key personnel during the term of the contract. Replacement personnel must be identified and have the same qualifications.
14. Prepare and submit written reports to Commission's Human Resource Manager, as requested.
15. Be available to answer questions and provide assistance to the Commission seven days per week, twenty-four hours a day. Pager and Mobile phone numbers of key personnel are to be provided by the Respondent to the Commission.

- Written analysis of available alternative insurance contracts and companies for PBC's consideration.
- Written timeline showing the necessary steps for the research, acquisition and implementation of insurance coverages.
- Draft Requests for Proposals for various benefit programs
- Model form agreements.
- For each policy proposed or offered for placement to the PBC, a full written disclosure, before placement of the coverage, of all compensation (whether guaranteed or contingent) that would be provided to the consultant for placement of that coverage, including, but not limited to, broker commissions or brokerages, incentives, market service agreement payments, or any other form of compensation.

SCHEDULE C COMPENSATION OF THE CONSULTANT

C.1 Compensation

C.1.1 The Consultant will be compensated on an annual fixed fee of Thirty Thousand Dollars (\$30,000) to be distributed in one payment once all benefit coverages are bound.

C.1.1.1 Unless otherwise provided herein, the Consultant, its affiliates and subsidiaries will not receive any fee, credit, rebate or item of value from an insurer, or any other party related to an insurer, as payment for either receiving or being considered for PBC Benefits coverage.

C.2 Changes to Scope

C.2.1 The Commission may compensate the Consultant for additional services that are not incorporated into the Scope of this agreement on a lump sum basis. Fees for such additional services will be agreed upon by the Consultant and the Commission prior to the incorporation of the additional scope to this agreement and must be incorporated by a written and executed amendment.

C.3 Submission of Invoices

C.3.1 The Consultant will submit invoices in accordance with paragraph 5.b of this agreement for the services to be provided. Invoices are to be submitted 30 days prior to payment due date.

SCHEDULE D INSURANCE REQUIREMENTS

The Consultant must provide and maintain at Consultant's own expense, until the term of the agreement and during the time period following expiration if Consultant is required to return and perform any additional work, the insurance coverages and requirements specified below, insuring all operations related to the Agreement.

A. Insurance To Be Provided

1) Workers Compensation and Employers Liability

Workers Compensation Insurance, as prescribed by applicable law covering all employees who are to provide a service under this Agreement and Employers Liability coverage with limits of not less than \$100,000 each accident or illness.

2) Commercial General Liability (Primary and Umbrella)

Commercial General Liability Insurance or equivalent with limits of \$2,000,000 per occurrence for bodily injury, personal injury, and property damage liability. Coverages must include the following: All premises and operations, products/completed operations separation of insureds, defense, and contractual liability (with no limitation endorsement). The Public Building Commission of Chicago is to be named as an additional insured on a primary, non-contributory basis any liability arising directly or indirectly from the Services.

3) Automobile Liability (Primary and Umbrella)

When any motor vehicles (owned, non-owned and hired) are used in connection with Services to be performed, the Consultant must provide Automobile Liability Insurance with limits of \$1,000,000 per occurrence for bodily injury and property damage. The Public Building Commission of Chicago is to be named as an additional insured on a primary, non-contributory basis.

4) Professional Liability/Errors and Omissions

When any professional consultants perform work in connection with this Agreement, Professional Liability Insurance/Errors and Omissions covering acts, errors, or omissions must be maintained with limits of not less than \$2,000,000. Coverage must include contractual liability. When policies are renewed or replaced, the policy retroactive date must coincide with, or precede, start of Services on the Agreement. A claims-made policy which is not renewed or replaced must have an extended reporting period of two (2) years.

B. Additional Requirements

Consultant must furnish the Public Building Commission, Richard J. Daley Center, 50 West Washington Street, Room 200, Chicago, IL 60602, original Certificates of Insurance, or such similar evidence, to be in force on the date of this Agreement, and Renewal Certificates of

Insurance, or such similar evidence, if the coverages have an expiration or renewal date occurring during the term of this Agreement. Consultant must submit evidence of insurance prior to Agreement award. The receipt of any certificate does not constitute agreement by the Commission that the insurance requirements in the Agreement have been fully met or that the insurance policies indicated on the certificate are in compliance with all Agreement requirements. The failure of the Commission to obtain certificates or other insurance evidence from Consultant is not a waiver by the Commission of any requirements for the Consultant to obtain and maintain the specified coverage. Consultant must advise all insurers of the Agreement provisions regarding insurance. Non-conforming insurance does not relieve Consultant of the obligation to provide insurance as specified in this Agreement. Nonfulfillment of the insurance conditions may constitute a violation of the Agreement, and the Commission retains the right to suspend this Agreement until proper evidence of insurance is provided, or the Agreement may be terminated.

The insurance must provide for sixty (60) days prior written notice to be given to the Commission in the event coverage is substantially changed, canceled or non-renewed.

Any deductibles or self-insured retentions on referenced insurance coverage must be borne by Consultant.

Consultant agrees that insurers waive their rights of subrogation against the Public Building Commission, its employees, elected officials, agents or representatives.

The coverage and limits furnished by Consultant in no way limit the Consultant's liabilities and responsibilities specified within the Agreement or by law.

Any insurance or self-insurance programs maintained by the Public Building Commission do not contribute with insurance provided by Consultant under this Agreement.

The required insurance to be carried is not limited by any limitations expressed in the indemnification language in this Agreement or any limitation placed on the indemnity in this Agreement given as a matter of law.

Consultant must require all Subcontractors to provide the insurance required in this Agreement, or Consultant may provide the coverages for Subcontractors. All Subcontractors are subject to the same insurance requirements of Consultant unless otherwise specified in this Agreement.

If Consultant or Subcontractor desires additional coverage, the party desiring the additional coverage is responsible for the acquisition and cost.

The Public Building Commission Risk Manager maintains the right to modify, delete, alter or change these requirements

Based on such certification(s) and any other information known or obtained by the Contractor, is not aware of any such subcontractor or subcontractor's affiliated entity or any agent, partner, employee or officer of such subcontractor or subcontractor's affiliated entity having engaged in or been convicted of (a) any of the conduct describe in Section II(A) (1)(a) or (b) of this certification; (b) bid-rigging, bid-rotating, or any similar offense of any state or the United States which contains the same elements as bid-rigging or bid-rotating, or having made an admission of guilt of the conduct described in Section II(A)(1)(a) or (b) which is matter of record but has/have not been prosecuted for such conduct.
2. The Contractor will, prior to using them as subcontractors, obtain from all subcontractors to be used in the performance of this contract or agreement, but not yet known by the Contractor at this time, certifications substantially in the form of this certification. The Contractor shall not, without the prior written permission of the Commission, use any of such subcontractors in the performance of this contract if the Contractor, based on such certifications or any other information known or obtained by Contractor, became aware of such subcontractor, subcontractor's affiliated entity or any agent, employee or officer of such subcontractor or subcontractor's affiliated entity having engaged in or been convicted of (a) any of the conduct describe in Section II(A)(1)(a) or (b) of this certification or (b) bid-rigging, bid-rotating or any similar offenses of any state or the United States which contains the same elements as bid-rigging or bid-rotating or having made an admission of guilt of the conduct described in Section II(A)(1)(a) or (b) which is a matter of record but has/have not been prosecuted for such conduct. 

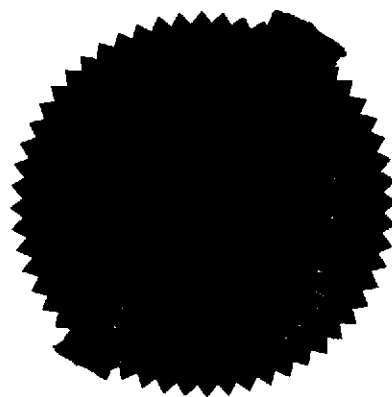

Notes 1-5 Disclosure Affidavit

1. Business entities are affiliated if, directly or indirectly, one controls or has the power to control the other, or if a third person controls or has the power to control both entities. 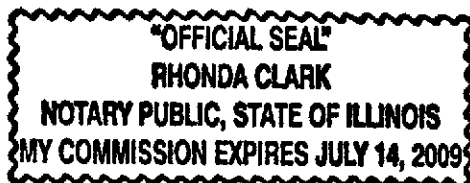
