

**THIRD AMENDMENT
ENGINE COMPANY 16

THIS THIRD AMENDMENT AGREEMENT is made and entered into as of the 10th day of April, 2012, and shall be deemed and taken as forming a part of the Agreement for Architect of Record Services for Engine Company 16 ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **INTERACTIVE DESIGN, INC.** ("Consultant") dated June 8, 2010 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Consultant have heretofore entered into an Agreement dated the 8th day of June, 2010, wherein the Consultant is to provide Architect of Record Services for the City of Chicago; and

WHEREAS, the Commission and Consultant now desire to amend the Agreement to include Additional Services performed and associated compensation due to Consultant;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. Recitals

THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.

2. Schedule A Scope of Services is amended to include that the Consultant shall perform the following Additional Services required for Engine Company 16:

- 2.1. Consultant will provide additional design services to reengineer the sewer connection to Wabash Avenue.
- 2.2. Consultant will provide additional design services to add camera revisions at monopole.
- 2.3. Consultant will provide additional design services to add new street resurfacing to mid-point of South Wabash Avenue between 40th and 39th Street.
- 2.4. Consultant will provide additional design services to add new sidewalk without planters to 40th Street.
- 2.5. Consultant will provide additional design services to add new accessible curb ramps.

3. Section I. Architect's Fee is revised as follows:

- 3.1 The Commission shall pay the Consultant a lump sum fee amount of \$2,550.00 for the satisfactory performance of the additional services outlined in Item 2.1.
- 3.2 The Commission shall pay the Consultant a lump sum fee amount of \$2,650.00 for the satisfactory performance of the additional services outlined in Item 2.2.

- 3.3 The Commission shall pay the Consultant a lump sum fee amount of \$1,712.00 for the satisfactory performance of the additional services outlined in Item 2.3.
- 3.4 The Commission shall pay the Consultant a lump sum fee amount of \$2,212.00 for the satisfactory performance of the additional services outlined in Item 2.4.
- 3.5 The Commission shall pay the Consultant a lump sum fee amount of \$3,462.00 for the satisfactory performance of the additional services outlined in Item 2.5.
- 3.6 The Commission shall pay the Architect a total lump sum fee of \$12,586.00 for the satisfactory performance of all of the Additional Services outlined in this Third Amendment.

Execution of this Amendment by the Consultant is duly authorized by the Consultant, and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.
