

**SECOND AMENDMENT
ARCHITECT OF RECORDS SERVICES
CHICAGO CHILDREN'S ADVOCACY CENTER
CONTRACT NUMBER PS1932**

THIS FIRST AMENDMENT AGREEMENT is made and entered into as of the 10th day of June 2014, and shall be deemed and taken as forming a part of the Agreement for Design Services at Chicago Children's Advocacy Center ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **Holabird & Root** ("Architect") dated June 12, 2012 with the like operation and effect as if the same were incorporated therein.

WITNESSETH:

WHEREAS, the Commission and Architect have heretofore entered into an Agreement dated the 12th day of June 2012, wherein the Architect is to provide Design Services for the Commission on behalf of Chicago Children's Advocacy Center of the City of Chicago; and

WHEREAS, the Commission and Architect now desire to amend the Agreement to include Additional Services performed and associated compensation due to Consultant;

NOW THEREFORE, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in, and amendments to the Agreement pursuant to this Amendment are as follows:

TERMS

1. **Recitals**
THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.
2. **Schedule A Scope of Services**
 - 2.1 To redesign the sanitary piping routing and revise the electrical layout of outlets and data to accommodate computer stations revisions
3. **Schedule D Compensation of the Architect**
 - 3.1 The Compensation paid to the Architect under this agreement is \$4,250.00.
 - 3.2 The Compensation is based on actual time and expenses using their standard hourly rates and in accordance with the Terms and Conditions for Professional Services dated June 10, 2014.

Execution of this Amendment by the Architect is duly authorized by the Architect and the signature(s) of each person signing on behalf of the Architect have been made with the complete and full authority to commit the Architect to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.

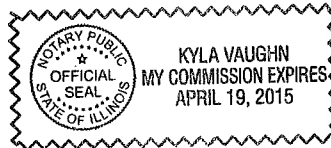
