

**FIRST AMENDMENT  
PHOTOGRAPHIC DOCUMENTATION SERVICES  
CONTRACT NUMBER PS2024**

**THIS FIRST AMENDMENT AGREEMENT** is made and entered into as of the 14<sup>TH</sup> day of April 2015, and shall be deemed and taken as forming a part of the Agreement for Photographic Documentation Services ("Agreement") by and between the **PUBLIC BUILDING COMMISSION OF CHICAGO**, a municipal corporation of the State of Illinois ("Commission") and **Multivista Construction Documentation** ("Consultant") dated May 13, 2014 with the like operation and effect as if the same were incorporated therein.

**WITNESSETH:**

**WHEREAS**, the Commission and Consultant have heretofore entered into an Agreement dated the 13<sup>th</sup> day of May 2014, wherein the Consultant is to provide Photographic Documentation Services for Various Sites for the Commission; and

**WHEREAS**, the Commission and Consultant now desire to amend the Agreement to include Additional Services performed and associated compensation due to Consultant;

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement and herein, the parties hereto mutually agree to amend the Agreement as hereinafter set forth.

It is agreed by and between the parties hereto that the sole modification of, changes in and amendments to the Agreement pursuant to this Amendment are as follows:

**TERMS**

1. **Recitals**  
**THE ABOVE RECITALS ARE EXPRESSLY INCORPORATED IN AND MADE A PART OF THE AMENDMENT AGREEMENT AS THOUGH FULLY SET FORTH HEREIN.**
2. **Schedule A      Scope of Services**
  - 2.1      The Consultant is to provide additional Photographic Documentation Services.
3. **Schedule D      Compensation of the Consultant**
  - 3.1      The Compensation paid to the Consultant under this Amendment is increased by \$150,000.00 for a total maximum compensation of \$300,000.00.

Execution of this Amendment by the Consultant is duly authorized by the Consultant and the signature(s) of each person signing on behalf of the Consultant have been made with the complete and full authority to commit the Consultant to all terms and conditions of this Amendment.

All capitalized terms not defined herein shall have the meaning ascribed to them in the agreement. Except as and to the extent that the terms of the Agreement are amended and modified herein, all terms of the Agreement shall remain in full force and effect.

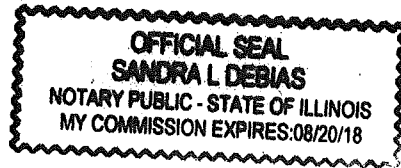
