WHEREAS, the bid of Brandenburg Industrial Service Company was the lowest responsible bid meeting the technical specifications received by the Commission for Building Groups B and E and Heneghan Wrecking Company submitted the lowest responsible bid for Building Groups C and D; and

WHEREAS, as part of its bid proposal, Brandenburg Industrial Service Company has advised the Commission that the surety on the performance and payment bond for Building Groups B and E to be supplied in the form set forth in the contract documents will be Continental Casualty Company, a corporate surety authorized to do business under the laws of the State of Illinois; and

WHEREAS, the staff of the Commission has recommended that Contract No. 1490, Building Groups B and E be awarded to Brandenburg Industrial Service Company and that Continental Casualty Company, proposed surety on the performance and payment bond, be accepted by the Commission; and

WHEREAS, as part of its bid proposal, Heneghan Wrecking Company has advised the Commission that the surety on the performance and payment bond for Building Groups C and D to be supplied in the form set forth in the contract documents will be Travelers Casualty and Surety Company of America, a corporate surety authorized to do business under the laws of the State of Illinois; and

WHEREAS, the staff of the Commission has recommended that Contract No. 1490, Building Groups C and D be awarded to Heneghan Wrecking Company and that Travelers Casualty and Surety Company of America, proposed surety on the performance and payment bond, be accepted by the Commission.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of the Public Building Commission hereby awards to Brandenburg Industrial Service Company Contract No. 1490, Building Groups B and E, Michael Reese Hospital Campus pursuant to the terms thereof for the Base Contract Price of \$7,743,000, Alternate \$237,000 for the Total Contract Price of \$7,980,000 and authorizes and directs the appropriate officers of the Public Building Commission of Chicago to take such action as may be required or advisable in order to consummate the award and to execute the contract.

BE IT FURTHER RESOLVED that the Public Building Commission of Chicago does hereby approve a performance and payment bond to be supplied in the form set forth in the contract documents comprising Contract No. 1490, Building Groups B and E, subject to the completion and delivery to the Commission of said form of bond by Brandenburg Industrial Service Company, as principal, and Continental Casualty Company, as surety, in the total contract price of \$7,980,000, and the Chairman is hereby authorized and directed to signify approval by the Commission of the executed bond.

BE IT FUTEHR RESOLVED that the Board of Commissioners of the Public Building Commission hereby awards to Heneghan Wrecking Company Contract No. 1490, Building Groups C and D, Michael Reese Hospital Campus pursuant to the terms thereof for the Base Contract Price of \$2,924,300, Alternate \$270,000 for the Total Contract Price of \$3,194,300 and authorizes and directs the appropriate officers of the Public Building Commission of Chicago to take such action as may be required or advisable in order to consummate the award and to execute the contract.

BE IT FURTHER RESOLVED that the Public Building Commission of Chicago does hereby approve a performance and payment bond to be supplied in the form set forth in the contract documents comprising Contract No. 1490, Building Groups C and D, subject to the completion and delivery to the Commission of said form of bond by Heneghan Wrecking Company, as principal, and Travelers Casualty and Surety Company of America, as surety, in the total contract price of \$3,194,300, and the Chairman is hereby authorized and directed to signify approval by the Commission of the executed bond.
