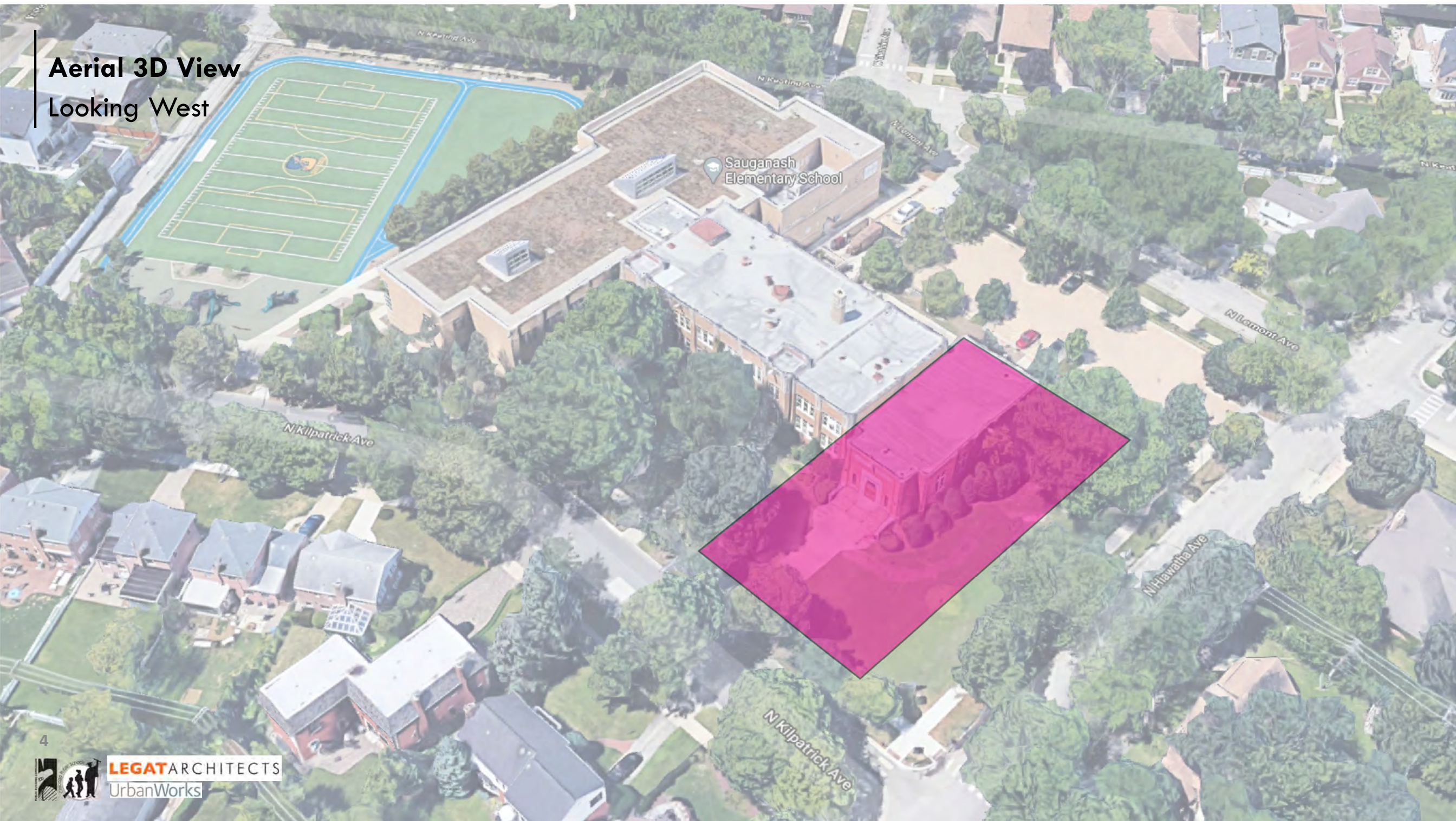

- Mechanical Plant & Chiller Well, Partial Basement
- Green Roof & Site Stormwater Infiltration

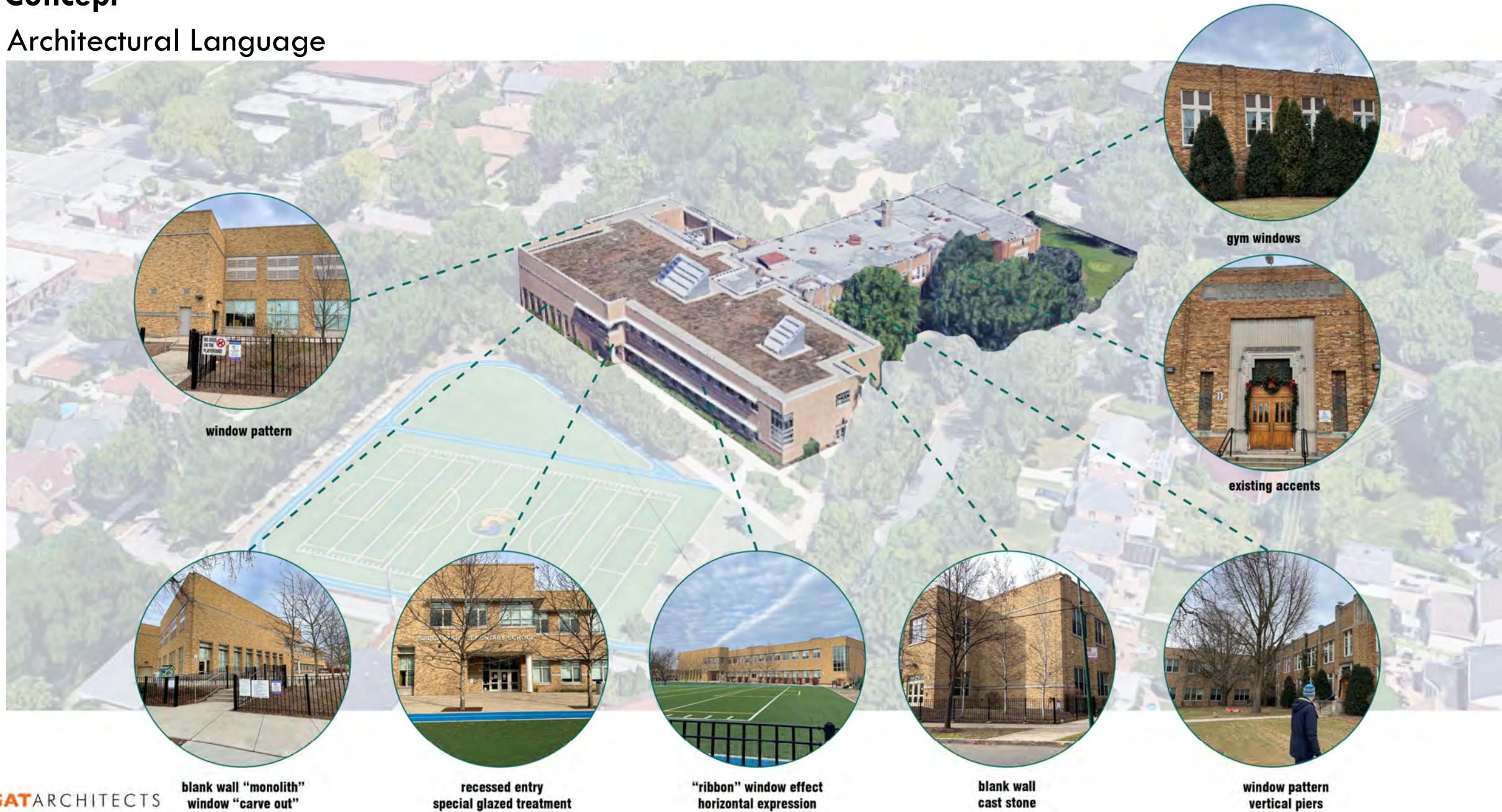
continuum

Sparked by the neighborhood's accomplishment of preserving and protecting the established identity of Sauganash, the new Annex II promotes/celebrates the concept of continuum.

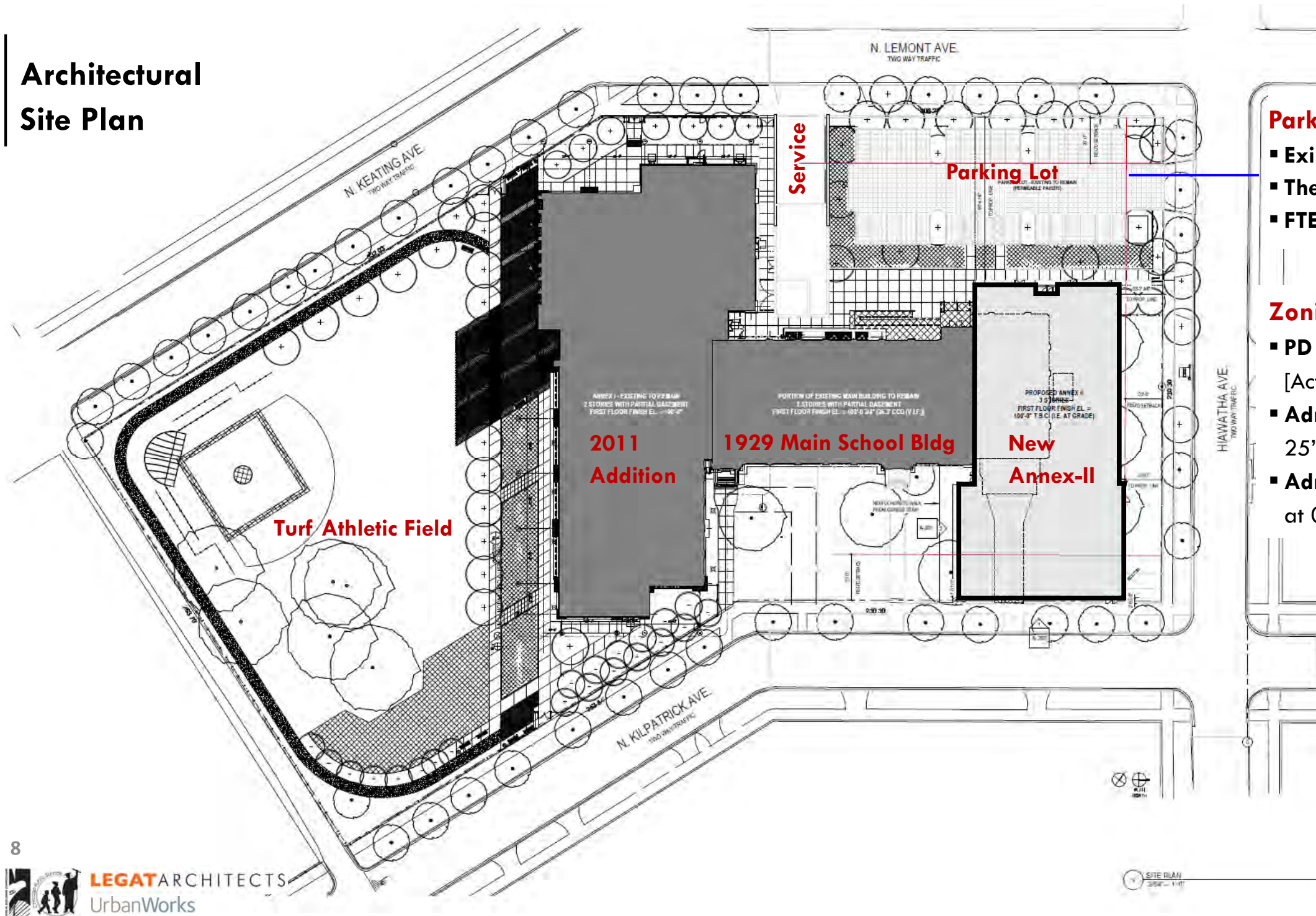

at 0.50 per RS-2 [Proposed 0.68]

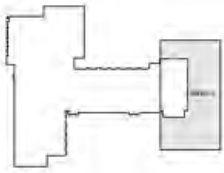


Landscape Plan - Existing

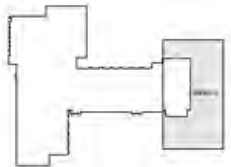

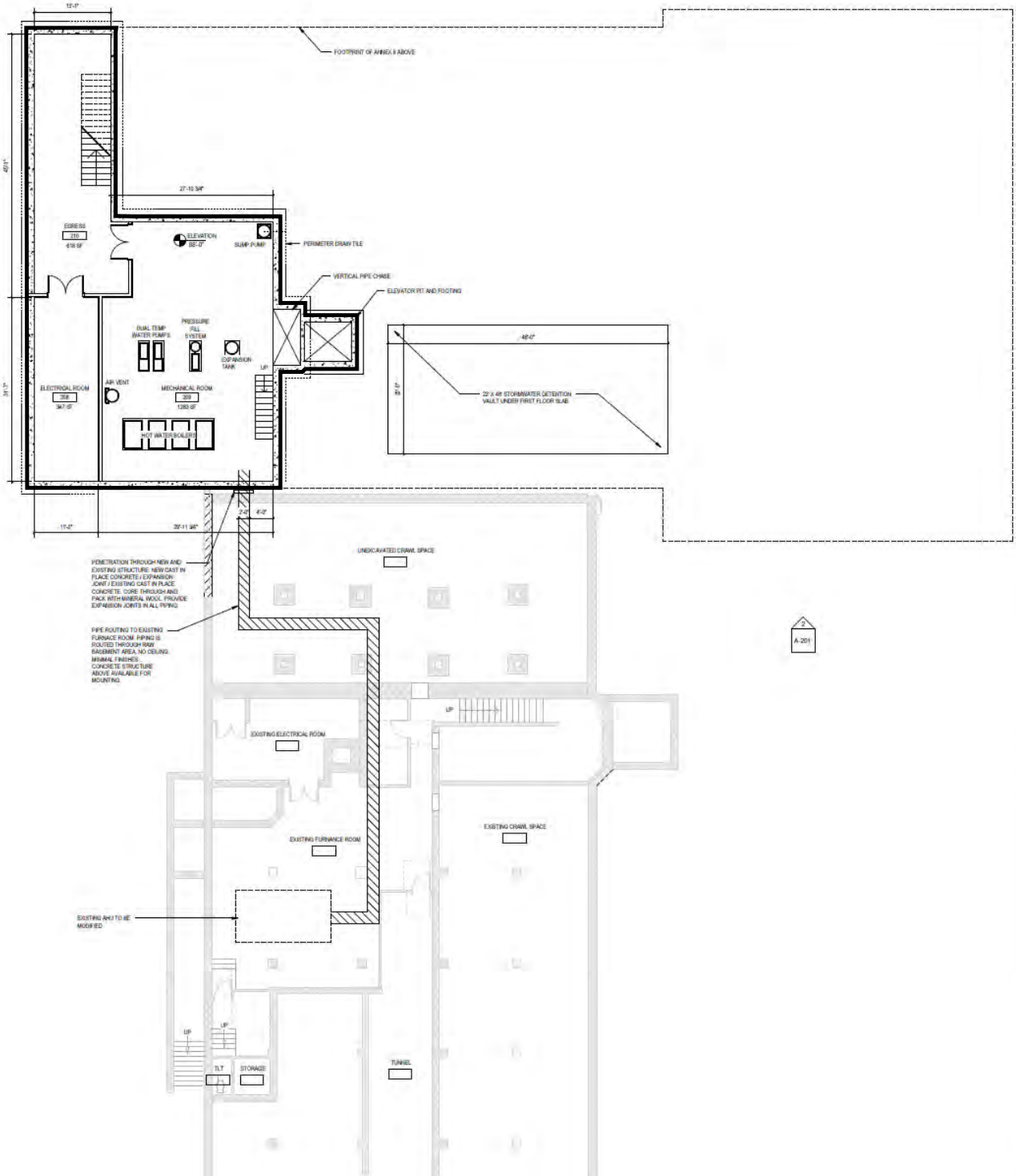

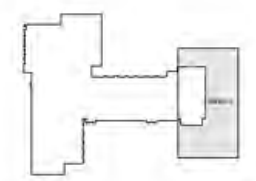


First Floor

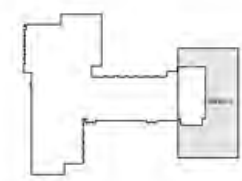


Second Floor

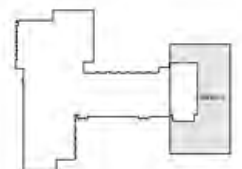


Third Floor Plan



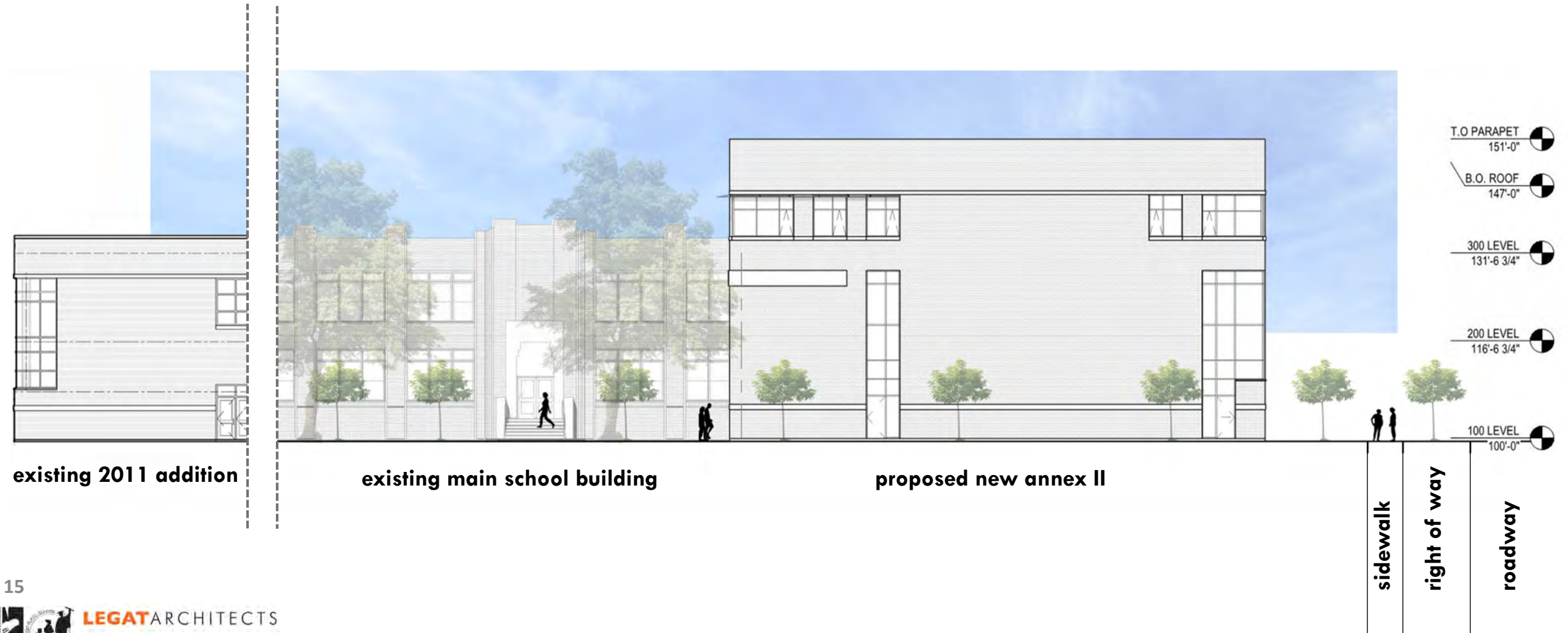

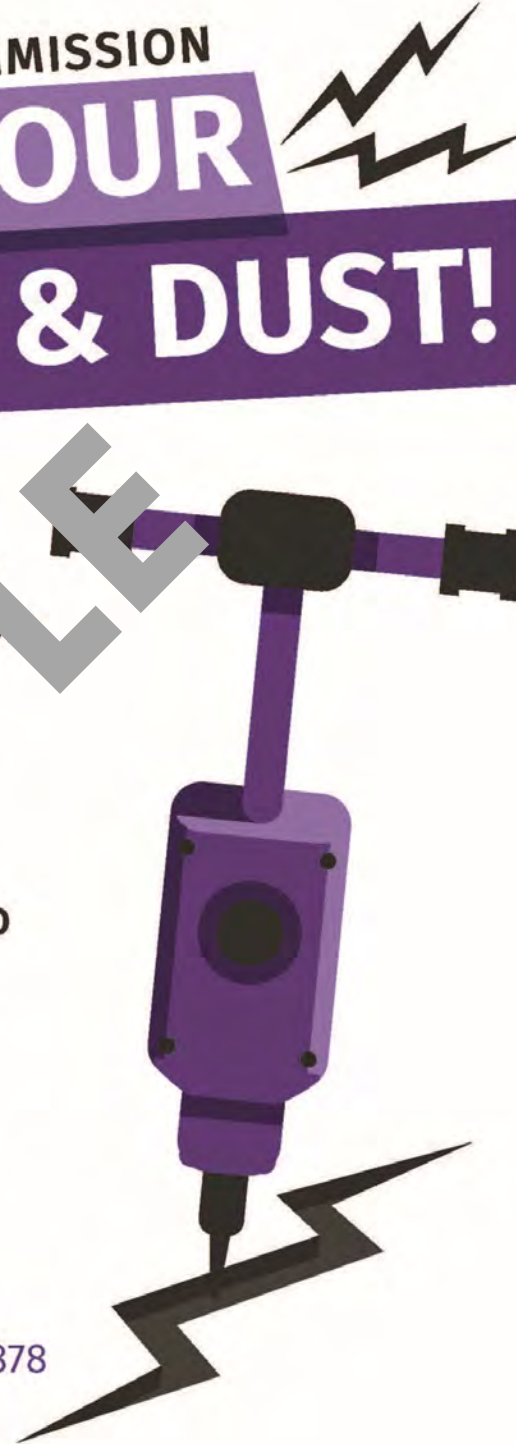

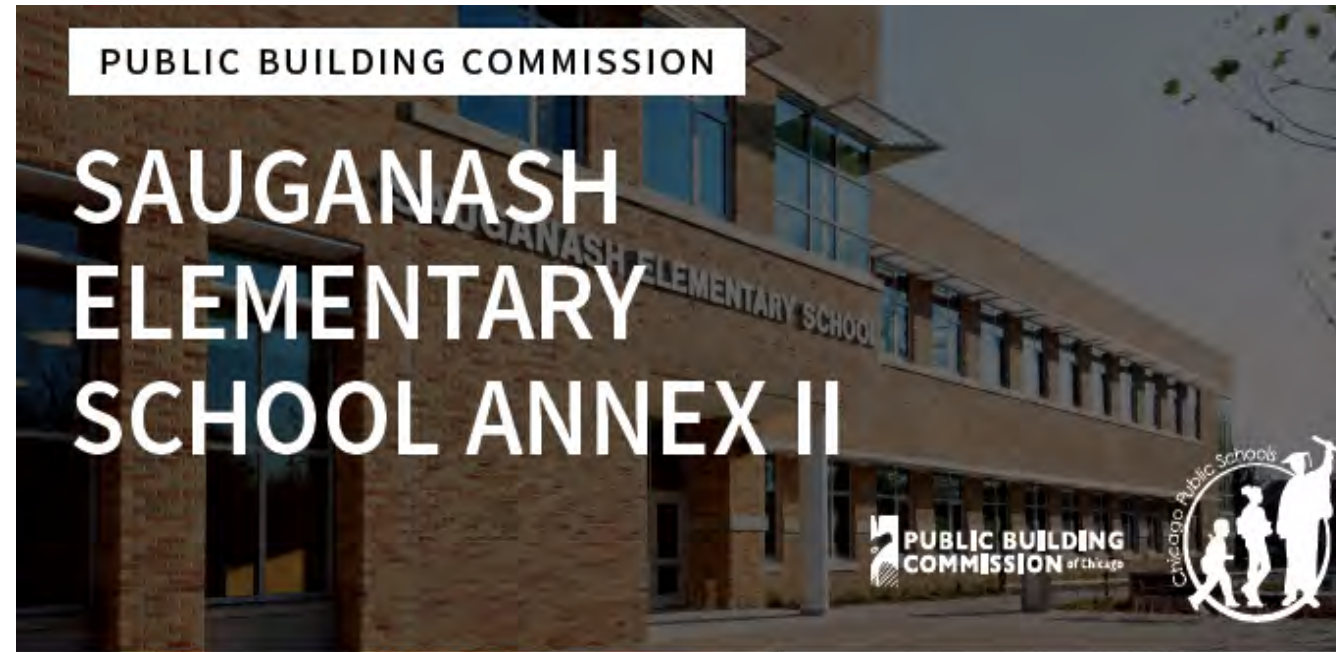
