

# PUBLIC BUILDING COMMISSION MINUTES OF THE VIRTUAL ADMINISTRATIVE OPERATIONS COMMITTEE MEETING HELD SEPTEMBER 2, 2020

The reading of the minutes of the March 4, 2020 Administrative Operations Committee meeting, which was previously distributed, was dispensed with. Upon motion duly made and seconded the minutes were unanimously adopted.

Pursuant to Section 2.06(g) of the Open Meetings Act, a public comment period was held. No comments or statements were presented by any persons.

Commissioner Randall asked about various field orders that are listed as work related to maintaining the schedule, for example; at Poe - work to maintain the time of completion requirements. Mr. Giderof responded that on some projects we directed the Construction Manager (CM) to accelerate their work to maintain the schedule. In the case of Poe, there were elements related to the permit process. He reported that one of the benefits of having a Construction Manager is their ability and flexibility to reconcile the schedule and determine how much time the CM can be mitigate. Working with our partners we are able to identify an Order of Magnitude amount and track those costs to verify what amount of acceleration was necessary.

The team also discussed the challenges due to the pandemic and the PBC's efforts to keep staff safe on the construction sites. The PBC's construction sites continued to operate even while facing labor, logistic and supply challenges. The Commissioners thanked the team for all their efforts to keep the staff safe and the projects operating.

The Chief Development Officer provided a recommendation to ratify Change Orders that were processed from April to August for nine projects as follows;

- Change Orders in the credit amount (\$797,933.10) for unused Allowances at the South Loop Elementary School Annex Project, in the credit amount of (\$612,925.11) at the Dore Elementary School Project and in the credit amount of (\$177,568.51) at the Sheridan Elementary School Annex Project.
- Change Orders for Liquidated Damages assessed in the credit amount (\$48,235.23) at the Oriole Park Elementary School Project and in the credit amount of (\$5,857.16) at the Columbia Explorers Modular Project.
- Change Orders in the amount of \$42,924.52 for work at the Lincoln Park High School Renovation Project and in the amount of \$81,674.73 at the Prussing Elementary School Annex and Renovation Project. The change orders for the school projects are all within the current Board of Education Funding Authority and PBC Board Undertaking amounts.

• Change Orders are for work at the Chicago Park District Group B Projects for Facility Renovations at Robichaux and Harrision Parks, in the amounts of \$67,906.03 and \$131,736.94. The change orders for park projects are within the Undertaking Authority approved for the Parks Capital Improvement Program at the January 10, 2017 Board Meeting.

The AO Committee accepted the reports from the Chief Development Officer.

The meeting was adjourned.
