The next item on the agenda was a presentation by Executive Director Sánchez regarding regular reports, development status and other matters. She welcomed the newest Commissioner of the Public Building Commission, Joyce Chapman, appointee of the Chicago Board of Education, and her family who were present. The Executive Director expressed appreciation that Commissioner Chapman would be bringing her skills and expertise as she joined the other members of the Board of Commissioners of the Public Building Commission.

The Executive Director advised the Commissioners regarding the opening of the oldest African American high school in Chicago, Wendell Phillips Academy High School. The projects consisted of the selective renovation of the existing school and the construction of a new 21,000 square foot annex facility which will house a gymnasium, multi-purpose room and sports Hall of Fame. The Executive Director stated that she was joined by Chairman Lightfoot along with other community leaders and Phillips alumni in opening the new facility. She also reported that the project achieved more than 85% minority journey workers and more than 30% female

apprentices. More than \$8 million was paid to contractors and professional service providers, with 32.39% MBE participation and 5.45% WBE participation. She further noted that the Public Building Commission was responsible for the design of the project, which will enhance the school as well as the community.

In addition, the Executive Director reported that the Public Building Commission received an award from Engineering News Record (also known as ENR Midwest) for the Hancock College Preparatory School for the best project in the k-12 category. The project was selected following a review of 64 projects by an independent panel consisting of architectural, engineering and construction experts. She acknowledged the design build team of KRM/ALL Masonry Joint Venture, an MBE firm. The Chairman congratulated the Executive Director and her staff on receiving the prestigious award. Discussion ensued regarding the installation of a plaque at the school in recognition of the award.

Finally, the Executive Director reported that the Public Building Commission participated in the Ninth (9th) Annual Procurement Vendor Fair along with City, State and other local public agencies. This event provided an opportunity for numerous contractors and individuals to obtain information regarding employment and contracting opportunities with the Public Building Commission and other agencies.

Following discussion and comment, the Executive Director's report was accepted.

The next item on the agenda was consideration of approval of an Undertaking Request from the Board of Education for the FY22 Kenwood High School Link and Mechanical Project located at 5015 South Blackstone Avenue (the "Project"). The Public Building Commission scope of services will include procurement, construction and close-out services as well as required oversight/coordination of the Architect of Record and design consultants engaged by the

Chicago Public Schools (“CPS”) for the completion of the Project. The Undertaking Budget identified by CPS for the Project is \$8,353,812, including \$400,000 previously authorized in the Formulation Request. Scope and budget exclusions for the Project will include: planning, design and permitting; environmental engineering consulting and oversight; environmental Reno/Demo consulting and oversight; utility coordination (ComED SEL); fixtures, furniture and equipment; and Commissioning Authority Services. CPS will confirm/clarify the items excluded from the Commission’s scope and the budget for the Project. Schedule considerations and other site logistics impacts will be provided for the development of the Project schedule and confirmed prior to the commencement of construction services.
