The meeting was called to order by Chairman Johnson, and the presence of a quorum was established. The Commissioners were advised that Commissioner Jose Maldonado had requested approval to participate in the meeting by remote means under the guidelines established by the Open Meetings Act since he was unable to attend the meeting due to reasons specified in the Open Meetings Act. It was moved and seconded that the Commissioners approve virtual participation at the meeting by Commissioner Jose Maldonado, and the following Resolution was adopted:

**BE IT RESOLVED** that the Board of Commissioners of the Public Building Commission does hereby approve the request for remote attendance at the meeting by Commissioner Jose Maldonado due to reasons specified in Section 7 of the Open Meetings Act (5 ILCS 120/7).

The next item on the agenda was a public participation period pursuant to Section 2.06(g) of the Open Meetings Act. The Commissioners were advised that there were no persons who had previously registered to provide comments under the guidelines established by Resolution No. 7611 approved by the Board of Commissioners on January 11, 2011.

The next item on the agenda was consideration of approval the minutes of the Regular Meeting of the Board of Commissioners held on December 12, 2023. The reading of said minutes, which had previously been distributed, was dispensed with and upon motion duly made and seconded, the minutes of the December 12, 2023 board meeting were unanimously approved.

The next item on the agenda was a report from Commissioner Maldonado regarding the Administrative Operations (AO) Committee meeting held on January 4, 2024. Commissioner Maldonado's report regarding the AO Committee meeting is summarized as follows:

The Director of Procurement reported on two (2) task order awards for Environmental Engineering Specialty Consultant Services to previously appointed firms. He also reported on the recommendation of the prequalification of forty (40) Class A-E General Contractors and the bid openings for two projects.

The Acting Executive Director reported that there were no Field Orders above the reporting threshold. He also provided a recommendation on a Change Order in the credit amount of (\$212,713.85) for the Wendell Phillips Academy High School Project.

The AO Committee accepted the recommendations and reports from the PBC representatives.

A copy of the Task Order Report is attached hereto as Exhibit "A".

Following consideration of the AO Committee report and upon motion duly made and seconded, the following Resolution was adopted by the Board of Commissioners:

#### **RESOLUTION NO. 8713**

**BE IT RESOLVED** that the Board of Commissioners of the Public Building Commission hereby approves and ratifies the change order for the Project as indicated on the document entitled, "Proposed Change Orders to the Administrative Operations Committee" and attached to the minutes of this meeting as **Exhibit "B"**.

Next, the Commissioners were presented with consideration of approval of the prequalification of General Contractors for License Classification Types A-E based upon the following categories: Class A – No single Project Value Limit; Class B – Limits up to \$10 million on a single project Class C – Limits up to \$5 million on a single project; Class D – Limits up to \$2 million on a single project; and Class E – Limits up to \$500,000 on a single project. The Commissioners were advised by the Acting Executive Director that, in an effort to build capacity within the general contracting community, the Public Building Commission issued a Request for

Qualifications (RFQ) from firms interested in becoming pre-qualified as General Contractors for Commission projects on August 7, 2023. Outreach efforts by the Commission included a Pre-Submission Conference and a Contractor Workshop session to assist the general contracting community in responding to the RFQ as well as public advertisements in the Chicago Sun Times. As a result, 40 responses were received from firms interested in becoming pre-qualified General Contractors on projects undertaken by the Commission. Each firm was evaluated by PBC staff with specific experience and knowledge of the subject matter on qualifications that included: technical competence and past performance; qualifications and relevant experience of key personnel; financial capacity; commitment to utilization of Minority Business Enterprises (MBE) and Women Business Enterprises (WBE), legal actions; insurance capacity; and safety and quality assurance/control plan. Based upon the overall consensus of the evaluation committee, 40 firms were recommended for pre-qualification in the various categories as noted above for a term through December 31, 2028.

During the discussion that ensued, it was noted that two of the firms (namely, All Construction Group (MBE) and BOWA Construction Group (MBE) were newly qualified for Class A projects). Moreover, GMA Construction Group (MBE) had "graduated" from Class D to Class A based upon increased bonding and financial capacity. It was further noted that 15 of the firms recommended for pre-qualification were either MBE or WBE or a combination of both. The Commissioners were advised by the Acting Executive Director that the bonding and financial capacity of the firms would be reviewed at the time of contract award to ensure that the firm remains responsible to bid on Public Building Commission projects. Commissioner Sax inquired regarding veteran-owned firms. Staff will follow up regarding that inquiry. Finally, the Commissioners commended the staff of the Commission for its work with the pre-qualification process. Upon motion duly made and seconded, the following Resolution was adopted:

The next item on the agenda was a report by the Acting Executive Director regarding regular reports, development status and other matters. He advised the Commissioners regarding the issuance of the Public Building Commission's Q4 Newsletter, "Construction News You Can

Use". The Newsletter featured an article regarding the completion of the Sauganash Elementary School project that included selective interior renovations to the existing school as well as a new three (3) story annex. The Newsletter also included an article that highlighted the partnership between the Public Building Commission and the City Colleges of Chicago to expand the West Side Learning Center to include a new addition that will house the Community Center for Teaching and Learning. The Community Center will include additional recreational and meeting space for students and the community and also serve as a multi-use space for special events including community, business and organizations.

Also included in the Newsletter were activities and events that the Commission's staff had attended in furtherance of PBC's commitment to community engagement. The Commission hosted a conference on December 14, 2023 with Assist Agencies to provide information regarding upcoming opportunities on Public Building Commission projects, continued outreach efforts, access to information and ways to reinforce existing and future partnerships. During the conference, there were discussions between representatives of the Public Building Commission and the Assist Agencies about ways to enhance communications with contractors and professional services providers. In addition, through the efforts of the Director of Compliance, Patrice Doyle, the Public Building Commission hosted an in-person and its first-ever Virtual Community Hiring Session for the Dett Elementary School Annex and Renovation Project to reaffirm its commitment to fostering local talent and community engagement. The Hiring Session provided a unique platform to explore opportunities on upcoming projects and embodied the Commission's commitment to investing in the local community and creating pathways to meaningful careers in the construction industry. Acting Executive Director Giderof advised that the Commission will continue to collaborate with the Assist Agencies and the local community

in providing access, awareness and availability to create meaningful connections between local residents and employment opportunities on Public Building Commission projects.

Following discussion, the Acting Executive Director's report was accepted.

The next item on the agenda was consideration of approval to award Contract C1605 for the Works Progress Administration (WPA) Street Reconstruction Project on West Fillmore Street (the "Project"). Acting Executive Director Giderof advised the Commissioners that following an invitation to all contractors for bids on the West Fillmore Street Project, the Public Building Commission received sealed bids from two (2) general contractors deemed eligible to bid as a result of the bid solicitation, as follows:

WHEREAS, as a part of its bid proposal, MQ Sewer and Water Contractors, Inc. dba MQ Construction Co. has advised the Commission that the surety on the performance and payment bond to be supplied in the form set forth in the contract documents will be Employers Mutual Casualty Company, corporate surety, authorized to do business under the laws of the State of Illinois; and
