Question:

It appears some of these alleys have contaminated soil in them, however there are no pay items for Special and/or Non-Special Waste Disposal to compensate the contractor for additional hauling & disposal costs associated with pay items where excavation is incidental (i.e. - sewer pipe & structures). The contract references the IDOT SSRBC for management of contaminated soil, however the appropriate pay items for disposal do not exist in this contract. Please include items for Special and/or Non-Special Waste Disposal, or clarify how this work will be paid for.

Response: For Special and Non-Special pre-existing material handling and disposal, Bidders are advised to refer to Contract Documents (Book 3, Volume 1) for requirements. The descriptions, units, and estimated quantities for the work are listed in the Schedule of Prices, Pay Items 1 and 2. Additionally, refer to environmental information included in the Contract Documents (Book 3) regarding pre-existing environmental conditions.
